

Charting the Future with AI Basics to Brilliance With TCS




Charting the Future with AI Basics to Brilliance With TCS

Recent CPD Events Unpacking the Australian Budget 2024-25



The Australian (Sydney) Chapter of ICAI hosted a successful event on **May 16, 2024**. This insightful session focused on unpacking the intricacies of the Australian Budget for the 2024-25 fiscal year. The highly respected **Paul Bloxham**, Chief Economist for Australia, NZ & Global Commodities at HSBC, led the discussion. Mr. Bloxham provided a comprehensive analysis of the key measures outlined in the budget and their potential impact on various sectors.

#### **Event Highlights:**

- Expert Breakdown: Paul Bloxham, Chief Economist for Australia, NZ & Global Commodities at HSBC, delivered a clear and insightful analysis of the 2024-25 Australian Budget. He explained complex measures in an accessible way, connecting them to the current economic climate.
- Short-Term vs. Long-Term Impact: Paul meticulously analyzed the budget's prospective immediate advantages and disadvantages, as well as its enduring effects on businesses and individuals.
- Engaging Discussion & Networking: The event sparked active participation with numerous questions during the Q&A session. It concluded with a "budget fever" networking session, promoting valuable connections among attendees.

#### Recap of Fringe Benefit Tax CPD Session



On **May 24, 2024**, the Australian (Sydney) Chapter of ICAI organised an insightful session on Fringe Benefit Tax. **Paul Mather CA**, provided an overview of the Fringe Benefits Tax (FBT) in Australia. He highlighted key milestones and discussed the latest updates to FBT rates and thresholds, emphasizing their impact on employer FBT liability calculations. The event

was moderated by Neelam Hirawath and concluded with a successful networking session.

#### **Key Highlights**

- Importance of Accurate Documentation: Paul emphasized the importance of maintaining accurate records, noting common mistakes such as incomplete records, missing details, and incorrect benefit categorization. He also highlighted the critical role of precise documentation in novated leases and car parking facilities, especially for 'ute' vehicles.
- Logbook Accuracy and Vehicle Use: He shared examples from the ATO regarding how minor errors can invalidate logbooks, stressing the importance of accurate records for business and personal vehicle use.
- Upcoming Changes for Electric Vehicles: The session informed attendees that the plug-in hybrid exemption will end on 1 April 2025 and discussed the implications for employers and employees.
- Salary Packaging and FBT Exemptions: He illustrated how salary packaging can lead to savings for both employers and employees, optimizing benefits to maximize take-home pay and reduce tax liability. Clarified conditions for FBT exemptions for motor vehicles, stressing adherence to ATO guidelines.
